COMMUNICATIONS:

Pursuant to Executive Order No. 203, signed by Governor Murphy on 12/21/2020, fire district elections have been postponed until April 20, 2021. Please note that while the election dates have been modified, there are no modifications to existing budget timelines. The Division is awaiting further guidance whether elections will be held utilizing mail-in ballots or having in-person voting. Officials will be notified by the Division once this has been decided.

The temporary budget percentage allowable per N.J.S.A. 40A:14-78.17 is increased from fourteen to thirty percent to accommodate the lengthening of time between the beginning of the fiscal year and the election on the approval of the fire district budget.
